Responsibilities for director, risk management

- Credit adjudication under terms and conditions of signed Delegated bank and Sovereign Credit Approval Authorities

- Review and perform additional analysis on credits presented to the CMRM group by Corporate Credit Products Europe
- Work with London operation risk to review credit risk excesses for London monitored credits
- Performing ongoing portfolio monitoring on London counterparty credits
- To be accountable for the AFC and AML strategy which supports the business strategy
- People strategies and resource management successfully implemented to meet agreed business objectives

Qualifications for director, risk management

 The candidate must have an in depth understanding of operational risk including Operational Risk Policy, Framework & Program elements such as RCSAs, KRIs, Scenario Analysis, Loss Analytics

- The candidate must be able to work successfully with a diversity of individuals and constituencies internally & externally, and to be adept at building consensus even amidst a dispersed operating environment and of making decisions despite, at times, a degree of ambiguity or incomplete information
